Dear Sir/Ma'am,

This is in continuation to our notice for "Transition of Connectivity/LTA/MTOA in line with CERC (Connectivity and GNA to the ISTS) Regulations, 2022" dated 13-04-2023 wherein requisite compliances for different provisions of Regulation 37 were published on the CTU website.

As per Regulation 37.6(2) of GNA Regulations, "...entities covered under Regulation 4.1 of these regulations which have been granted Long Term Access to the target region, shall furnish Conn-BG3 @ Rs. 2 lakh/MW. On furnishing such Conn-BG3, these entities shall be treated as Connectivity grantee under these regulations having GNA corresponding to such Long Term Access...".

Details of such entities were also deliberated in the 19th CMETS-ER held on 30-05-2023, wherein it was decided that the same shall be considered as Connectivity granted under GNA Regulations having GNA corresponding to such LTA, as per Regulation 37.6(2).

The list of all entities of ER granted GNA under Regulation 37.6(2) of GNA Regulations, 2022 upon submission of applicable Conn-BG3 is attached at **Annexure-I**.
