

Notice to Stage-I Grantees/Applicants regarding refund of application fee

[Dated: 22.12.2023]

Based on the Regulation 37.1 of the GNA Regulations, 2022, Clause 26(x) of the “Detailed Procedure for Connectivity and GNA” and CTUIL notices dated 06.04.2023 and 27.06.2023 published on CTU website, following two categories of Stage-I applicants/grantees who had not applied for Stage-II connectivity by 05-04-2023 (i.e. effective date of GNA Regulations, 2022) are eligible to claim refund of the application fees submitted with their Stage-I applications:

Category- A:

Stage-I connectivity grantees (who had not applied for Stage-II connectivity by 05-04-2023), who had applied afresh for connectivity as per GNA Regulation along with applicable fees latest by 31-07-2023 or before completion of 2 years from the date of grant of Stage-I Connectivity (whichever is earlier) and their Connectivity application submitted under GNA Regulation is neither closed nor withdrawn by the applicants prior to the grant of in-principle grant of Connectivity.

Category-B:

Stage-I connectivity applicants (who had not applied for Stage-II connectivity by 05-04-2023), to whom Intimation for grant of Stage-I connectivity has not been issued.

Accordingly, all the eligible Stage-I applicants/grantees who are fulfilling the eligibility under any of the above categories may request for refund of their Stage-I application fee in the enclosed **FORMAT-CAT-A** or **FORMAT-CAT-B**, whichever is applicable:
