Agenda for 2nd Meeting for Reallocation of Bays at Fatehgarh-III PS scheduled to be held on 03.08.2023

A meeting for Reallocation of connectivity bays at Fatehgarh-III , Bhadla-II PS & Bikaner-II PS vacated post GNA Transition to other Grantees/applicants in Rajasthan RE complexes was held on 20.06.2023. In the meeting, the reallocation of bays at Bhadla-II PS & Bikaner-II PS was finalized. However, at Fatehgarh-III PS, the vacated bays were reallocated to applicant on provisional basis. It was deliberated that after reallocation, some margin is still available at Fatehgarh-III PS (section-2), Bhadla-II PS and Bikaner-II PS and the same will be offered to the new applicants who apply for connectivity under GNA regulation based on their priority and willingness. The same shall also be updated on the CTUIL website.

Further, based on SECI request to consider GIB clearance issues for developers at Fatehgarh-2 PS for reallocation and consequent provisional reallocation to developers at Fatehgarh-IV PS (Sec-1 & 2), it was decided that another meeting shall be held in 2nd week of July'23 for finalization of allocation. On specific issues raised by SECI regarding GIB at Fatehgarh-II PS, it was also decided that, in case CTUIL receives any direction from the Ministry to specifically allocate these bays and available margin, the same will be considered and the connectivity of applicants opting to shift to Fatehgarh-III PS will be restored at Fatehgarh-IV PS.

In the above meeting, M/s Prerak Greentech had opted to shift from Bhadla-III to Bhadla-II PS and it was decided to allocate one no. of 220 kV line bay at Bhadla-II PS(out of the 2 no. of bay surrendered by M/s Adani) to M/s Prerak. However, subsequent to the meeting, M/s Prerak vide letter dated 04.07.2023 informed their decision to continue with connectivity at Bhadla-III PS. Since no other applicant granted connectivity at Bhadla-III PS opted for Bhadla-III PS in the reallocation meeting, the earlier vacated bays(2 no.)/capacity at Bhadla-II PS shall be offered to new applicants in Bhadla complex based on their application priority.

Subsequent to GNA Transition opted by M/s Azure in May'23, now M/s Azure vide letter dated 29.06.2023 informed that they are unable to furnish Conn BGs for LTA & connectivity of cumulative quantum of 1833 MW granted at Fatehgarh-III PS(Sec-2) at 400 kV level. M/s Azure had been granted connectivity of 2600 MW & LTA of 1933 MW at Fatehgarh-III PS(Sec-2) at 400 kV level.

Details of connectivity & LTA granted to M/s Azure are as below:

- 400 kV line bay-1: LTA & Connectivity 600 MW (500 +100)
 - 400 kV line bay-2: LTA & Connectivity 1000 MW (500 +500)
 - 400 kV line bay-3: Connectivity 1000 MW (500 +500) with 333 MW LTA (667 MW Conn. without LTA)
- Total: 2600 MW (1933 MW LTA & 667 MW Conn. without LTA)**

Out of the above, M/s Azure has expressed inability for submission of Conn BGs for transition of LTA & Connectivity quantum of 1833 MW (500 MW at Bay1+1000(500+500) MW at Bay 2 + 333 MW at Bay3). Therefore, the LTA and corresponding connectivity quantum of 1833 MW is considered as surrendered. The retained quantum of connectivity & LTA by M/s Azure are as below:

- 400 kV line bay-1: LTA & Connectivity 100 MW-Opted for Transition
- 400 kV line bay-2: LTA & Connectivity 0 MW -Completely Surrendered
- 400 kV line bay-3: Connectivity 667 MW (167 +500) -Opted for Transition

Total: 767 MW (with 100 MW LTA & 667 MW Conn. without LTA)

M/s Azure vide letter dated 29.06.2023 also requested to shift the 100 MW LTA granted at bay-1 to an alternate 220 kV Bay basis the margins available at Fatehgarh-III S/S. However, for optimal utilization of the 400 kV bay(bay-3 with 667 MW), the above LTA quantum of 100 MW(granted at bay-1) shall be merged with the bay-3 with combined connectivity of 767 MW or vice versa(i.e. 667 MW shall be merged with 100 MW at bay-1). Therefore, it is proposed to merge the quantum of 667 MW connectivity & 100 MW(Connectivity+ LTA) into a single bay of 400 kV and the connectivity granted to M/s Azure will be revised accordingly after completion of transition process. The implementation of 400 kV line bay shall be taken up upon completion of transition process matching with the schedule of 100 MW LTA or 667(167+500) MW Connectivity whichever is earlier.

Accordingly, 1833 MW of capacity (along with 2 no of 400 kV line bays) vacated by M/s Azure will be considered for reallocation to other applicants granted connectivity at Fatehgarh-IV PS based on application priority, consent for GNA Transition and willingness.

In the previous meeting, it was decided that out of earlier 1500 MW capacity surrendered at Fatehgarh-III PS, 300 MW at section-1 was not allocated to any applicant due to N-1 criteria limit. Same will be utilized by upcoming BESS. Out of the remaining 1200 MW surrendered it was decided that reallocation of 900MW at 400kV level of Fatehgarh-III PS (Section-2) shall be considered for reallocation, however 300MW at 220kV level of Fatehgarh-III PS (Section-2) shall be allocated to Fatehgarh-IV PS applicant on provisional basis. Accordingly in the meeting, based on applicants priority & willingness, 800 MW at 400 kV was allocated to M/s Renew for its multiple applications granted at Fatehgarh-IV PS & 250 MW at 220 kV was allocated to M/s Khaba on provisional basis. On specific issued raised by SECI regarding GIB at Fatehgarh-II PS, it was decided that, in case CTUIL receives any direction from ministry to specifically allocate these bays and available margin to Fatehgarh-II PS grantees, the connectivity of M/s Khaba shall be restored at Fatehgarh-IV PS.

Further, M/s Renew vide letter dated 23.06.2023 & 30.06.2023 informed that, Renew Dinkar Urja Pvt. Ltd.(100 MW) under the PPA with PSPCL have committed delivery of energy at Fatehgarh-IV PS and they are disabled from unilaterally shifting from Fatehgarh-

IV to Fatehgarh-III. Since this will change the offer priority to RE applicants including Renew, there is necessity to carry out reallocation at Fatehgarh-III PS afresh for above capacity. It is advised to M/s Renew to take prior management approval regarding their decision to opt for reallocation in the meeting to avoid such issues.

Decision on connectivity of M/s Khaba at Fatehgarh-III PS(allocated on provisional basis in previous meeting) need to be finalized in this meeting. Further, total quantum of 2783 MW (900MW(400 kV bay -1 no.)+1833 MW(400 kV bays-2 no.) + 50 MW(on sharing basis with M/S Khaba at 220 kV)) at Fatehgarh-III PS(Sec-2) at 400 kV level shall be considered for reallocation to applicants at Fatehgarh-IV PS based on their priority & willingness.

Among Fatehgarh-IV PS applicants, reallocation option shall be offered first to Fatehgarh-IV Sec-1 applicants with both Connectivity + LTA followed by applicants with only Connectivity. Any remaining capacity shall be offered to Fatehgarh-IV Sec-2 applicants in the same order (applicants with both Connectivity & LTA followed by Connectivity only applicants) as both the stations (Sec-1 & Sec-2)of Fatehgarh-IV PS are being developed in different phases & timelines.

Kindly note that in case of no participation in the meeting by applicant, it will be construed that the applicant is not willing for reallocation and therefore they will not be considered for the subject reallocation.

Further, it is advised to all applicants to take prior management approval regarding their decision regarding opting for reallocation in the meeting. The decision taken by the applicant in the meeting shall be considered as final and based on that the reallocation shall be finalized and no changes shall be allowed afterwards.
