Minutes of meeting for reallocation of Connectivity at Fatehgarh-II PS held on
19.01.2024

CTU welcomed the participants to the meeting (List of participants enclosed at Annex-I).

It was informed that earlier meetings for reallocation of connectivity were held on 20.06.2023 & 03.08.2023. In the above meetings, the connectivity quantum surrendered under GNA Transition at Fatehgarh-III, Bhadla-II PS etc. were offered to applicants granted connectivity at Fatehgarh-IV PS, Bhadla-III PS etc.

In the above meetings, it was informed that some connectivity at Fatehgarh-II PS is surrendered however Fatehgarh-II PS is located inside the additional Important area identified by the supreme court constituted GIB committee. Due to this reason, many applicants who had been granted connectivity at Fatehgarh-II PS were awaiting clearance for their overhead DTL from the GIB committee. In view of the above, the connectivity capacity surrendered at Fatehgarh-II PS was not considered for reallocation option till clarity of GIB clearance of other RE developers DTL at Fatehgarh-II PS.

Further, considering GIB clearance issues, one developer at Fatehgarh-II PS had also showed willingness to shift their connectivity to Fatehgarh-III PS. M/s Eden Renewables Pvt. Ltd. vide letter dated 20.05.2023, requested shifting of connectivity to nearest alternative ISTS Substation i.e. Fatehgarh-III PS due to non-receipt of permission from Supreme Court constituted GIB committee for laying of overhead Transmission line to Fatehgarh-II PS. Further, the Eden petition is also subjudice with Hon'ble CERC. Due to pending clearance from GIB committee, 400 kV Fatehgarh-II PS – Bhadla-III PS is also delayed under Phase-III scheme.

As the connectivity grantees at Fatehgarh-II PS had surrendered/offered for shifting to alternative locations and no request regarding reallocation of capacity at Fatehgarh-II PS was received by CTU, the reallocation of connectivity at Fatehgarh-II PS was not carried out though margin available at Fatehgarh-II PS was displayed on CTU website since July'23.

It was informed that recently CTUIL has received applications for connectivity by M/s ACME Cleantech at Fatehgarh-II PS for total 850 MW (600MW + 250MW) on 29.11.2023 & 30.11.2023 respectively. Further, a representation has also been received from ABC RJ Land 01 Private Limited vide letters dated 20.12.23, 27.12.23 & 08.01.24 that in view of spare capacity available at Fatehgarh-II PS, they intend to get connectivity for their project granted connectivity at Fatehgarh-IV PS (110 MW+270 MW) at Fatehgarh-II PS. M/s ABC RJ has mentioned that they have requested for connectivity sanction at Fatehgarh- II substation based on the land parcel they have already acquired in the vicinity of Fatehgarh-II substation while retaining the connectivity granted for 380 MW at Fatehgarh - IV substation.

Further, it was informed that, in view of the requirement of comprehensive examination of the matter, two no. of applications of M/s ACME Cleantech applied for connectivity at Fatehgarh-II PS were deferred for discussion in the 27th CMETS NR meeting.

It was also informed that M/s ACME vide letter dated 09.01.24 had also raised its concerns on not taking up its applications (600 MW+250 MW) for grant at Fatehgarh-II PS in 27th CMETS-NR meeting held on 10/01/24. M/s ACME has also mentioned that ABC RJ Land 01 should have made another application at Fatehgarh-II PS after its application is disposed off by grant of connectivity at Fatehgarh-IV PS and it cannot claim connectivity at Fatehgarh-II PS at a later stage without having any live application pending with CTU. In view of the above, M/s ACME was also invited to this meeting.

In the meeting, M/s ABC informed the background on the matter. M/s ABC informed that they had earlier applied (year 2021) for St-II connectivity for 380 MW (110 MW+270 MW) at

Fatehgarh-II PS on land basis (land in vicinity of Fatehgarh-II PS). However, in view of connectivity capacity exhausted at Fatehgarh-II/Fatehgarh-III PS, there were granted connectivity at Fatehgarh-IV PS with the understanding that in case of bay vacancy at Fatehgarh-II PS in future, option to move from Fatehgarh-II IV PS to Fatehgarh-II PS or Fatehgarh-III PS shall be based on application priority.

CTU asked ABC why they didn't submit any formal request until Dec'23 for connectivity shifting to Fatehgarh-II PS as vacancy margins were displayed on CTU website since Jul'23, however this request triggered only when M/s ACME made application in Nov'23. Further, as discussed in Jun'23 reallocation meeting, Fatehgarh-II PS was not considered for reallocation option till clarity of GIB clearance of other RE developers DTL at Fatehgarh-II PS and that clarity is still not emerged on the issues. One of such case of M/s Eden to shift out of Fatehgarh-II PS is still pending. Furthermore, no interest was ever shown by any RE developer for availing Connectivity at Fatehgarh-II PS in past (till Nov'23) including in Jun'23 & Aug'23 Reallocation meeting. As the status of GIB issues didn't change at Fatehgarh-II PS after reallocation meetings, status quo was maintained and the process at Fatehgarh-II PS was neither started nor stopped at any moment. Based on the ACME applications (Nov'23) and ABC letter for connectivity shifting (Dec'23) to Fatehgarh-II PS, the issue surfaced first time only for willingness of connectivity or reallocation at Fatehgarh-II PS.

M/s ABC mentioned that in the Hon'ble Minister (NRE & Power) meeting dated 01/11/23, they indicated their willingness to shift their connectivity (380 MW) to Fatehgarh-II PS with DTL through underground cables. However, issued MOM didn't include reference of such matter for which they will take up the matter with MNRE for corrigendum.

CTUIL informed that it is gathered that some of the existing grantees at Fatehgarh-II PS are developing hybrid (O/H+U/G Cable in Additional important area) dedicated tr. lines. Now despite ongoing challenges of GIB clearances for overhead lines, M/s ABC RJ has showed intent of shifting their connectivity from Fatehgarh-IV PS to Fatehgarh-II PS. Based on M/s ABC RJ request and applications from ACME, this exercise is being initiated.

CTUIL informed that as per the existing practice of CTUIL, the shifting/reallocation of generators is carried out for substations in the same vicinity/complex in order to give the opportunity to the generation developers who were granted connectivity at a new substation due to non-availability of bay/margin at earlier substation. In case allocated bay(s) at earlier substation is vacated at a later stage due to surrender/revocation of connectivity, applicants at new substation are offered shifting/reallocation to earlier station in order of their application priority and willingness.

This shall facilitate avoidance of stranded capacity of transmission system at earlier station, defer investments on new transmission infrastructure at new substation, conservation of RoW due to reduced length of Dedicated Transmission Line (DTL) in some cases and thus ensuring development of an efficient and economical transmission system.

This exercise is carried out in a transparent manner in consultation with RE developers, SECI, CEA etc. in Reallocation meeting followed by monthly Consultation meeting (CMETS) with all stakeholders.

In case of shifting of cases with both Connectivity & LTA to earlier substation, it is ensured that start date of LTA is not postponed avoiding stranding of any transmission infrastructure during such reallocation process. **In case of shifting of connectivity cases, if the schedule of the bay at earlier substation is later than the schedule of bay at new substation, then the liability of bay charges for the intervening period is attached to reallocated grantees.**

Considering above, it was decided to conduct a meeting for reallocation of connectivity at Fatehgarh-II PS from grantees of Fatehgarh-III & Fatehgarh-IV PS as per the application priority and agenda was issued thereof.

It was also informed that, in line with discussions held in previous reallocation meetings in Jun'23, under connectivity regulation 2009, LTA & connectivity were different products. Grant of connectivity involved connectivity transmission system for interconnection of generation project with ISTS as well as allocation of bay at pooling station whereas LTA involved allocation of transmission system for onward transfer of power. However, under GNA regulation, connectivity is a merged product i.e. connectivity comes with deemed GNA (in place of LTA). Therefore, grant of connectivity under GNA regulations not only involves allocation of bays along with connectivity transmission system but also involve allocation of transmission system for onward transfer of power. For applicants with both connectivity & LTA, transmission system for onward transfer is already allocated. However, for applicants with only connectivity, transmission system is yet to be allocated. Therefore, under GNA regime, for reallocation of bays as well as onward transmission system, priority is being accorded to grantees/applicants with both Connectivity & LTA over connectivity only. Further, after allocation to grantees/applicants with both Connectivity & LTA, the remaining margin shall be offered to Stage-II connectivity grantees/applicants. After allocation to applicants granted Stage-II only grantees, the remaining margin shall be offered to applicants who have applied for connectivity under GNA regime(Apr'23 onwards). Inter se priority among applicants shall be as per their application date & timestamp.

Further, CTUIL also informed regarding the reallocation at Fatehgarh-II as below:

- Fatehgarh-III PS (Sec-1) tr. system is already commissioned in Dec'23, therefore such grantees at Fatehgarh-III PS (Sec-1) will not be considered for present re-allocation at Fatehgarh-II PS.
- Fatehgarh-III (Sec-2) & Fatehgarh-IV (Sec-1) PS and its associated transmission system is already awarded and under various stages of implementation (schedule: Feb'25 to Sep'25).
- Fatehgarh-II PS is an existing station, however some of the onward corridors for effectiveness of connectivity under GNA beyond Fatehgarh-II PS viz. Ph-II Part-D (Ph-1) i.e. 765kV Sikar-II -Khetri & Sikar-II- Narela are under advanced stage of bidding and SPV yet to be transferred (18 months schedule).

Further, 400kV Jhatikara – Dwarka 400kV D/c line (Quad) is also required which has been awarded (Nov'23) to POWERGRID under RTM with 18 months schedule. However, recently POWERGRID citing severe ROW issues in Delhi area has requested to increase the implementation timeline to at least 24 months along with change in tower/conductor configuration. The matter shall be deliberated in ensuing NCT meeting.

- In case of some GNA transitioned cases, wherever WR-NR Inter-regional corridors (Feb'26), were allocated, will be retained in the revised tr. system
- In the new connectivity applications, requirement of WR-NR Inter-regional corridors (Feb'26) will be applicable.
- In all cases where reallocation option is opted by grantees, since new right is created at reallocated station, the right of connectivity grant at earlier Station shall no longer be available.

Accordingly, the RE applicants granted connectivity in Fatehgarh-III(Sec-II) & Fatehgarh-IV PS (Sec-I & Sec-II) were offered to opt for 1000 MW connectivity (400kV-500 MW & 220kV-500 MW) at Fatehgarh-II PS as per the application priority.

CTUIL also informed that in case of any margin/bay vacancy created at Fatehgarh-III PS or Fatehgarh-IV PS due to above reallocation process to Fatehgarh-II PS, option will be given to subsequent applicants granted connectivity at Fatehgarh-IV in the list below followed by

applicants at Barmer PS subsequently. In case of any vacancy remaining even after this exercise, same shall be offered to the new applicants.

Applicants were asked to confirm the application details including application priority mentioned in the agenda before the meeting. In view of no comments received by any applicant, the same application priority as per agenda was followed.

Accordingly, list of applicants granted connectivity at Fatehgarh-III PS(Sec-II), Fatehgarh-IV PS(Sec-I) & Fatehgarh-IV PS(Sec-II) as per application priority and the reallocation option exercised by them are as below:

In the meeting, it was informed that, in view of not opting for reallocation by any applicant at Fatehgarh-III PS or Fatehgarh-IV PS including ABC RJ (270 MW+110 MW), the margin of 1000 MW connectivity (500 MW at 400 kV & 500 MW at 220 kV) at Fatehgarh-II PS may be offered to new applicants.

On query of CTU, M/s ABC RJ reconfirmed that though they have expressed interest in connectivity shifting to Fatehgarh-II PS through letters, now as per their management decision they are not opting for reallocation to Fatehgarh-II PS. M/s ABC RJ also indicated that they wish to change their land parcel from existing parcel near Fatehgarh-II to Fatehgarh-IV PS as per CERC 11/SM/2023 order (reg. change in land) for their 380 MW project. CTU advised ABC RJ to apply to CTU formally in this regard.

CTUIL informed that the reallocation process is being carried out in a transparent manner. However, in view of various concerns raised by M/s ABC RJ & M/s ACME it has been decided to prepare a detailed procedure (SoP) in this regard which is currently in draft stage. The same shall be finalized and uploaded in the CTUIL website for comments. CTUIL requested all to give their comments on the same so that the same can be finalized for better clarity on the process.

Subsequent to above meeting, CERC vide its order dated 19.01.2024 on petition no. 268/MP/2023 & 269/MP/2023 has directed CTUIL to carry out fresh reallocations in terms of the Order.
