M/s Azure Power India Pvt. Ltd. (APIPL) was granted 100 MW connectivity at 400kV level of Fatehgarh-III PS (Sec-II) in sharing with M/s Aditya Birla Renewables Subsidiary Limited (ABRSL). M/s ABRSL was the Lead Generator. Now, M/s APIPL has relinquished its 100 MW connectivity w.e.f. 21.05.2025. This development has created 100 MW margin at 400kV level Fatehgarh-III PS (Sec-II) in sharing with M/s ABRSL.

Further, 50 MW connectivity was agreed to be granted at 220kV level of Barmer-I PS to M/s Hexa Climate Solutions Private Limited (HCSPL) in sharing with M/s Hinduja Renewables Energy Private Limited (HREPL) in 36th Consultation Meeting for Evolving Transmission Schemes in Northern Region (CMETS-NR) held on 15.01.2025. However, above connectivity was closed due to non-submission of requisite Conn-BGs in stipulated time as per GNA Regulations, 2022. This has resulted into creation of 50 MW margin at 220kV level of Barmer-I PS in sharing with M/s HREPL.

Accordingly, meeting regarding reallocation of margin at following pooling stations is scheduled at **20.06.2025 at 03:30 PM through VC**:

1. Fatehgarh – Barmer Complex

Substation: Fatehgarh-III PS (Sec-I) (100 MW margin at 400kV in sharing with M/s ABRSL)

Eligible Entities: Entities granted/agreed connectivity at Fatehgarh-IV PS (Sec-I & II), Barmer-I, Barmer-II, Barmer-III & Barmer-IV

Substation: Barmer-I PS (50 MW margin at 220kV in sharing with M/s HREPL)*

Eligible Entities: Entities granted/agreed connectivity at Barmer-III & Barmer-IV

Agenda in this regard is enclosed herewith.

As per existing practice, criteria for reallocation is as under:

- i. Vacated bay/margin at a pooling station shall be offered to eligible entities at next/subsequent pooling stations of same complex (List of complexes in NR is enclosed at **Annexure-I**) based on the application priority & willingness for reallocation.
- ii. Under GNA regime, priority of eligible entities shall be treated as per following order for each of the pooling station:
 - a. Entities transitioned under GNA Regulations, 2022 with both connectivity & LTA as per their LTA application date & time stamp.
 - b. Entities transitioned under GNA Regulations, 2022 with Stage-II Connectivity only as per their Stage-II Connectivity application date & time stamp.

- c. Entities under GNA Regulations, 2022 as per their connectivity application date & time stamp
- iii. Due to reallocation, start date of connectivity/GNA cannot be postponed. However, in case bay is already awarded at present pooling station, reallocated entity shall be liable to pay the bay charges for the intervening period.
- iv. It may be noted that the reallocation of connectivity is an optional exercise carried out by RE developers. Therefore, timelines for all the compliances to be met by connectivity applicants/grantees/entities as applicable under Connectivity & GNA Regulations 2022 like Conn BG submission, Land BG, Financial Closure etc. remains unchanged due to reallocation.
- v. Liability of transmission charges, if any, for any entity after reallocation shall be in accordance with CERC Sharing Regulations, 2022.
- vi. All entities are required to take prior management approval regarding their decision for opting for reallocation in the meeting. The decision taken by the applicant in the meeting shall be considered as final and based on that the reallocation shall be finalized and no changes shall be allowed afterwards.
- vii. In case of no participation in the meeting by entity, it will be construed that the applicant is not willing for reallocation and therefore they will not be considered for the subject reallocation.
- viii. Any vacancy/margin creation at any pooling station/section due to reallocation, same shall be offered to eligible entities of subsequent pooling stations/sections of the same complex in the same meeting.
- ix. In case the margin being considered for re-allocation at any pooling station was available at the time of grant of connectivity to an eligible entity at subsequent pooling station for allocation but not availed, then such entity shall not be eligible for reallocation for such margin. In such case, entities who are granted connectivity at subsequent pooling stations in the same complex after the grant of connectivity to the **vacating entity**, shall only be considered eligible for reallocation.
- x. In case of any capacity remains vacant even after this reallocation meeting, same shall be offered to new applicants based on their application priority.

** It may be noted that vacated margin (50 MW in sharing at 220kV) at Barmer-I PS was available for grant before allocation to M/s Hexa climate (Application Date – **24.10.2024**) and such information was available at CTUIL website. Since entities in Fatehgarh-Barmer Complex, till application of Hexa climate (24.10.2024) did not avail the margin, as per point no. (viii) such entities are proposed not to be eligible for reallocation of 50 MW. Considering above, entities who have applied for connectivity after Hexa climate (24.10.24) are being considered for reallocation of 50 MW at 220kV level of Barmer-I PS in sharing with M/s HREPL.*
