As per 1st proviso of Regulation 37.10(a) of CERC GNA Regulations 2022, in case Connectivity application has been received under LoA/PPA route before effectiveness of 3rd amendment (09.09.2025) and Connectivity quantum sought is more than Contracted capacity mentioned in the LoA/PPA and In-principle intimation has not been issued as of 09.09.2025), in such cases the applicant shall convert the application as per 3rd amendment. Relevant provision is quoted as below:

"Provided that if an application for grant of Connectivity has been made by an entity covered under clause (a) of Regulation 5.8(xi) of these regulations, where Installed capacity is more than the LOA or PPA quantum and application based on LOA or PPA has been made at single location or multiple locations and intimation for in-principle grant of such Connectivity has not been issued by the Nodal Agency as on the date of coming into effect of third amendment of these regulations, the applicant, within one month shall request the Nodal Agency to convert the application as an application under third amendment of these regulations and submit the modified application, failing which the Nodal Agency shall process the application in accordance with the provisions under third amendment of these regulations, and in case the connectivity has been applied for multilocation based on one LoA or PPA, Nodal Agency shall grant Connectivity for the location where the Installed capacity is highest."

Accordingly, a MS Forms along with link to submit documents was put up on CTU website to convert the balance Connectivity (Connectivity sought minus Contracted capacity) to Land or Land BG Route.

After one month of effectiveness of 3rd amendment, it has been observed that 15 applicants have filed the above form. Out of them, 11 applicants have filed the form incorrectly. Out of remaining 4 applicants who have filed the form correctly, only 1 has submitted requisite documents.

Present meeting has been convened to provide a last opportunity to all eligible applicants to convert their remaining quantum of Connectivity to Land/Land BG Route, failing which appropriate action shall be taken in line with the Regulations.
