# Advisory for submission of requisite documents for waiver of inter-state transmission charges and losses on transmission of electricity generated from solar and wind sources of energy

CERC, vide notification no. No. L-1/44/2010-CERC dated 27th March, 2019 for Sixth amendment to CERC (Sharing of inter-State Transmission Charges & Losses) Regulations, 2010, notified waiver of inter-state transmission charges and losses on transmission of electricity generated from solar and wind sources of energy which is as under:-

#### Sub-clause (aa) to Clause (1) of Regulation 7 of Principal Regulations:-

"(aa) No transmission charges and losses for the use of ISTS network shall be payable for the generation based on solar and wind power resources for a period of 25 years from the date of commercial operation of such generation projects if they fulfill the following conditions:

- (i) Such generation capacity has been awarded through competitive bidding process in accordance with the guidelines issued by the Central Government:
- (ii) Such generation capacity has been declared under commercial operation between 13.2.2018 till 31.3.2022;
- (iii) Power Purchase Agreement(s) have been executed for sale of such generation capacity to all entities including Distribution Companies for compliance of their renewable purchase obligations."

In view of the above requirements, henceforth generation projects based on solar and wind power resources are advised to submit the following documents towards fulfillment of the provisions for waiver of transmission charges and losses for the use of ISTS network upon declaration of commercial operation of such generation projects failing which applicable transmission charges shall be raised as per CERC Regulations:

- (i) Declaration under **FORMAT-I** regarding waiver of transmission charges.
- (ii) Letter of Award (LOA) issued by designated agency that project has been awarded through competitive bidding process in accordance with the guidelines issued by Central Government.
- (iii) Certificate for date and MW of commercial operation of the generation project.
- (iv) Certificate from entities including DISCOM(s) that the executed PPAs with the solar and wind power resources are for compliance of their renewable purchase obligations.
