Note –

- LTA includes CGS allocation/LTOA/deemed LTA.
- In case LTA application is under process and option for conversion of application is exercised under Regulation 37.1, the corresponding LTA quantum may be reduced from the connectivity quantum to be converted under Regulation 37.2. If LTA application under process is withdrawn under Regulation 37.1 then full quantum of connectivity may be considered for conversion under Regulation 37.2. Conversion of LTA application shall have higher priority over the connectivity application.
