This is with reference to Office Memorandum Ref. No. C/CTU/Al/00/13th CCTP dated 08.06.2023 issued by CTU wherein Transmission Scheme "*Implementation of 1 no. 400kV bay at Kallam PS for interconnection of RE project of Torrent Solar Power Pvt. Ltd. (TSPPL)*" was approved to be implemented by Kallam Transmission Ltd. (a subsidiary of India Grid Trust) with an implementation timeframe of 30.12.2024.

Subsequently, in the meeting held on 24.01.2024 amongst RE developers, it was deliberated that the implementation schedule for 1 no. 400kV line bay at Kallam PS [for interconnection of Torrent Solar Power Pvt. Ltd. (TSPPL)] being developed by Kallam Transmission Ltd. (a subsidiary of India Grid Trust) may be revised from 30.12.2024 to 31.03.2025, matching with the schedule of TSPPL.

In view of the above, only the implementation timeframe of Transmission scheme "Implementation of 1 no. 400kV bay at Kallam PS for interconnection of RE project of Torrent Solar Power Pvt. Ltd. (TSPPL)" is hereby revised from 30.12.2024 to 31.03.2025 with the remaining contents unchanged.
