The undersigned is directed to inform that in the 36th meeting of NCT held on 30.12.2025, it was decided to delink the scope of “Creation of 400 kV switchyard along with Installation of 2x1500 MVA, 765/400 kV ICTs at Vataman (AIS) with 2x125 MVar (420 kV) Bus Reactors” from “Transmission system for offshore wind zone phase -1 (500 MW VGF off coast of Gujarat for subzone B3)” and continue implementation of the below stated scope of works with revised scheme name as **‘Transmission System for reliable power supply to Dholera area’** without any change to the implementation time-frame:
